We continue to complain about the state of the roads around the village and despite feedback from the County Council nothing seems to happen.

Regarding the cemetery, we now have a rubbish bin that is emptied by the Council in the hope the area is kept clean and tidy. More importantly at long last, after many years of trying, we now have planning permission to extend the cemetery once a few conditions are met. This is excellent news as the original cemetery is fast running out of available plots.
