147/15 Electronic Planning Service

The sending of papers plans through the post from ERYC will cease from Monday 27 June 2016 in respect of all plans and applications received on or after this date. Town and Parish Councils will are now able to reply through consultee access.

ERYC has given as much notice as possible to enable Parish Councils to make themselves ready for this change. This ensures that financial arrangements are in place for the change to purchase any equipment needed.

148/15 School Pond Grass Cutting

Mr Green of Field House, Burton Fleming has now left the village and is therefore unable to continue cutting the grass behind the school pond. A request for a volunteer to help with this area has been put in the newsletter but no response has been received to date. Members felt that this should be reviewed in Spring with a possibility of incorporating the work into the grass cutting contract.

149/15 Christmas Tree

Thanks were expressed to Cllr Stephen Wells who has kindly offered to donate a Christmas tree for the Village Green this year.

Cllr K Wells to liaise with Mr Woodcock with regard to the installation of the tree and lights.

150/15 Thwing Road Bridge

Following concerns from residents regarding heavy articulated lorries using Thwing Road Bridge to enter the village, the Clerk was asked to investigate whether Highways inspect the bridge on a regular basis.

151/15 Flood Management

Planned highway maintenance work for South Street/Bridlington following the Flood of 2012 was initially delayed to allow the flood risk team time to undertake surveys and to establish which preventative measures to introduce.

It has been confirmed that any flood alleviation work will not affect the Highway in this area and Andy Maclachlen, Principal Engineer, ERYC is to contact the Highways Team so that it can commence with the planned maintenance scheme.

The Clerk was asked to seek clarification of whether this maintenance would include upgrading the railings as previously agreed.

The Clerk was also asked to obtain a telemetry reading and to clarify what contingency plans are in place should the Gypsey Race flow.

152/15 Cemetery

Mason Clark Associates are in the frame to start discussions with the Environment Agency following a request for help from the Parish Council to ERYC. The likely charge for this would be £84.00 per hour to be paid by Burton Fleming Parish Council.

It was mooted that a cap of 10 hours (£840.00) was put in place to stop the costs of the discussions spiraling too high. The Parish Council would manage the contract itself rather than paying ERYC.

Before Members make a decision, Cllr K Wells requested the opportunity to consult with Mr Copeland for further advice and this was agreed. Members would then be required to email their agreement on any pending decisions.

ACTION BY CHAIRMAN

153/15 Transparency Code Bid

The bid has now been put together for a cost of approximately £1,300.00. This will include computer equipment, printers, software, training, staff time and website set up costs.

154/15 Village Transport

Phoenix Travel, ERYC's contractor, gave notice to cease operating this contract in March 2015. A temporary replacement has been provided by Acklams Coaches and the cost of this temporary arrangement has seen the cost of the service double.

This arrangement will continue in its current format until February 2016 after which time the service will change. This will give ERYC time to consult with Parish Councils and service users. Councillors and some residents had previously given feedback which had been forwarded as follows to EYRC:

• ERYC has approved planning for the development of 9 dwellings within Burton Fleming's infrastructure.

- This housing is classed as affordable family housing and as such people wishing to buy these properties may have limited access to their own transport.
- Residents require access to a Saturday service for shopping, particularly those residents who work in the village during the week and cannot use the Wednesday and Thursday services.
- Older children and teenagers require independent access to a Saturday service to Bridlington to enable them to meet with friends, take a Saturday job, access the new swimming pool facilities in the town.

Cllr K Wells attended a Parish Transport Champions Meeting on behalf to the Clerk which was being held by ERYC. The aim of the meeting was to help Parish Councils to tackle their own transport needs as the Authority make austerity cuts to the transport they provide.
